(1) This option vests 33 1/3% on October 8, 2015 and 8 1/3% per quarter over the next eight following quarters.

Each PRSU represents a contingent right to receive between zero and two shares of common stock. The reported number of securities represents the target number of shares that may be earned,

(4) which will be adjusted by between 0% and 160% based upon the Company achieving certain pre-established target levels of adjusted non-GAAP operating income plus interest expense over a two-year performance period commencing on January 1, 2014 and ending on December 31, 2015. The target number of shares will then be adjusted by between 0% and 125% based on the Company's total shareholder return (TSR) relative to the TSR of the S&P 500 IT Sector over the performance period.

(5) The earned shares of common stock vest 50% on each of December 31, 2015 and 2016.
