- (2) The option vests 625 shares on 4/28/2006 then remaining shares vest monthly through 4/28/2009.
- (3) The option vests 312 shares on 4/28/2006 then remaining shares vest monthly through 4/28/2009.
- (4) The restricted stock units vest 33 1/3% on 8/9/2006 then 6.6667% every 3 months thereafter for the next 10 quarters.
