The shares include warrants to
- (1)** purchase an additional 35,000,000 shares of common stock of AMD at an exercise price of \$0.01 per share held by West Coast Hitech L.P. The warrants are currently exercisable and have a ten-year term. The reporting person is the Executive Director of the Mubadala Industry business unit of Mubadala.
- (2)** Each restricted stock unit represents a contingent right to receive one share of common stock.
